### Australia Business Visitor Visa Requirements

#### 1. Business Visitor Activities (Short-Term Visits):

- **Visitor Visa (Subclass 600) – Business Visitor Stream:** This visa is suitable for short-term business visits, such as attending conferences, negotiations, or exploratory business trips.

    - **Expression of Interest (EOI):** Submit an EOI through the SkillSelect system.
    - **State or Territory Nomination:** Obtain a nomination from an Australian state or territory government.
    - **Visa Application:** Once nominated, apply for the visa and provide necessary documentation, including business plans, financial records, and health and character assessments.
- **Business Talent (Permanent) Visa (Subclass 132):** This permanent visa is for high-caliber business owners or part-owners who want to do business in Australia.

- **Significant Business History Stream:** For experienced business owners with a genuine and realistic commitment to participate in the management of a new or existing business in Australia.
- **Venture Capital Entrepreneur Stream:** For individuals who have sourced venture capital funding from a member of the Australian Investment Council.
- **Application Process:**
  - **Expression of Interest (EOI):** Submit an EOI through SkillSelect.
  - **State or Territory Nomination:** Secure a nomination from a state or territory government.
  - **Visa Application:** After nomination, lodge your visa application with supporting documents.
